Credit Terms

It is understood and agreed that any credit granted by On Track – Kuntz & Company Inc. to the Customer is on the following terms and conditions.

- All invoices are payable on the 15th of the following month. Acceptable methods of payment include company cheque, cash or debit card.
- All invoices shall be deemed accurate and accepted by the Customer unless questioned within 30 days of “invoice date”
- Risk in the goods shall transfer to the Customer upon delivery of the goods even though title has not passed. All monies due by the Customer shall be due without set-off or abatement.
- A Service Charge will be charged to you on any balance outstanding at the end of each month at the rate of 1.5% per month.
- The undersigned will be responsible for legal costs on a solicitor & client basis or any other third party expense paid by On Track – Kuntz & Company Inc. for the recovery of any debt owing.
- A signed facsimile of the Credit Agreement shall have the same force and effect as the original.
- The domestic laws of the Province of Alberta shall govern this Credit Agreement and the Customer hereby attorns to the jurisdiction of the courts of the Province of Alberta.
- The Customer accepts that On Track – Kuntz & Company Inc. shall not be liable for any damages for any goods supplied to the Customer beyond the price of defective goods supplied and in particular, On Track – Kuntz & Company Inc. will not be responsible for any consequential damages or third party liabilities.
- Upon default by the Customer, On Track – Kuntz & Company Inc., has the right to declare all accounts with the customer to be immediately due and payable, stop goods in transit to the Customer and/or take possession of any goods supplied by On Track – Kuntz & Company Inc. to the Customer to the extent it deems necessary to secure payment of all monies due and owing. Default shall include non-payment by the Customer of one invoice or account when due and owing or if the Customer becomes insolvent.
